To close down Service Centres

167. Sardar Kultar Singh Sandhwan, M.L.A:- Will the Chief Minister be pleased to state:-

- (a) whether it is a fact that the State Govt. has ordered to close down 67 service centres whereat the income was low and expenditure more;
- (b) whether it is also a fact that as per the terms of written agreement signed between Akali-BJP Government and service centre company that if any service center is close down before completion of its time limit, the loss so caused will be compensated by the State Govt.
- (c) if the replies to part (a) and (b) above be in the affirmative whether penalty of Rs 125 crore will not have to be borne by the State Government in lieu of closure of 67 centres before completion of the time limit of the same;
- (d) as to what the Govt. has contemplated in respect of employees working in service centres who will get unemployed due to closing of the same?

Amendment with regard to imposition of Transport tax on Tractor

- (c) whether it is also a fact that the forcible donation receipt from Rs 10,000 to Rs 20,000 in the name of District Red Cross Society is being issued to the persons acquiring arms license in some districts of the State even now; if so, the names of the Deputy Commissioners of the districts held responsible for forcible donation being collected?
