In pursuance of Rule 18 of the Rules of Procedure and Conduct of Business in the Punjab Vidhan Sabha (Punjab Legislative Assembly) the Hon'ble Speaker informed the House that the Governor has been pleased to address the Punjab Vidhan Sabha on 1st March, 2021 at 11.00 A.M under Article 176 (1) of the Constitution of India. The Hon'ble Speaker laid a copy of the Address on the Table of the House.

The Secretary laid on the table of the House a statement showing the details of the bills passed by the 15th Vidhan Sabha during its Tenth (Special)/Eleventh/Twelfth/Thirteenth (Special) Sessions, which have since been assented to by the Governor..

4. Announcement by the Hon'ble Speaker

"I would like to inform the House that Parliamentary Affairs Ministry of Govt. of India has launched e-vidhan project for the legislative institutions of entire India under the digital India programme and for this National e-vidhan Application (NEVA) has been developed. On its implementation the papers to be laid on the table of the House would be laid in a digitized manner. Exchange of information between Vidhan Sabha and its Hon'ble Members and between Vidhan Sabha and all the departments of the State would begin via electronic mode. This way the House proceeding would go paperless, that would save paper in large quantity and make the Government reap profit worth crores of rupees every year.

It gives me pleasure in informing you all that among all the States of the country ours is the first State to sign M.O.U with the Central Government for this purpose and Punjab Vidhan Sabha has received the honour of securing first place for making requisite entry of data in this application. Presently, the Central Government has approved this project worth Rs 12 crores 31 lacs for Punjab out of which 60 percent amount is to be provided by the Centre and 40 percent by the Government of Punjab. The Central Government has released Rs 1,47,72,612 as first instalment of 20 percent and our Govt. has also released the amount of its share for this purpose.



To provide digitized information to Hon'ble Members touch screen devices would be installed on the tables of each member to connect these devices to internet, Wi-fi nodes are to be installed in the chamber of the House. Apart from this required cables are also to be laid for providing Wi-fi connectivity in Vidhan Sabha building.

Punjab Vidhan Sabha Secretariat shall take every measure in maintaining the heritage status of this building but if there would be any requirement for any change at some time in implementation of this important project of Government of India for which the House and the Speaker are competent and are not answerable to anyone.

I would also like to inform all the Hon'ble Members that the Mobile App of National e-vidhan application is also available which can be downloaded from Android users Google play store and Apple users Apple store. Apart from uploading the Governor's address of this session to Vidhan Sabha's website it has also been uploaded to this app and budget speech shall also be uploaded to this app. Apart from this other information is also available on this app that would prove beneficial for the Hon'ble Members. As the touch screen devices are yet to be installed in the House, therefore, the Hon'ble Members can make use of their mobile phones for using this app.

Its our endeavour that the forthcoming Monsoon Session of Punjab Vidhan Sabha be made paperless, which besides saving crores of rupees would also prove beneficial for our environment as well because saving papers will also save trees in thousands. Before implementing this project of paperless Vidhan Sabha, arrangements will be made to provide proper training to all the Hon'ble Members and assistance and means of every sort will also be provided.

I hope all the Hon'ble Members will cooperate in going with the time in this era of technology."
