Members of the Indian National Congress present in the House staged a walk-out from the House as a mark of protest for not given time to speak during Zero Hour.

VII. Announcement by the Hon'ble Chief Minister regarding fixing the price of sugarcane as Rs. 380/- per quintal.

The Chief Minister made an announcement to hike sugarcane price from Rs. 360/- per quintal to Rs. 380/- per quintal which would entail an additional expenditure of Rs. 200 crore on the State Exchequer.

VIII. Chief Minister thanks Central Government for naming Mohali Airport after the name of Shaheed Bhagat Singh

The Chief Minister thanked the Central Government for naming Mohali Airport after the name of Shaheed Bhagat Singh on the demand of all Punjabis and the country and he congratulated all of them.

IX. <u>Announcement by the Chief Minister regarding naming of Halwara</u> Airport after the name of Shaheed Kartar Singh Sarabha

The Chief Minister announced that whenever he will be called regarding upgrading of the Halwara Airport to Civil Airport, he will try to name it after the name of Shaheed Kartar Singh Sarabha.

X. <u>Announcement by the Chief Minister Regarding Order to S.I.Ts for Speedy Investigation</u>

The Chief Minister announced that the S.I.Ts which were formed by the previous Governments, are being ordered to speed-up the investigation. He said that if our Guru is not safe in our own house and the sacrilege incident could not be investigated for so many years, then what is our responsibility. He assured that speedy investigation will be conducted by deputing the officers especially in the cases of Kotkapura, Behbal Kalan, Bargari and whatsoever the position or influence the offender holds, the law should be equal for all. The Chief Minister also assured to make efforts that the Government will do justice in case of any legal implication rising while taking decisions regarding regularization of employees or pertaining to serious crime like sacrilege.
