# 8. <u>Legislative Business</u>

#### 1. The Punjab Goods and Services Tax (Amendment) Bill, 2023

The Finance Minister introduced The Punjab Goods and Services Tax (Amendment) Bill, 2023 and also moved that the Bill be taken into consideration at once.

The motion was put to the vote of the House and carried unanimously.

Shri Budh Ram, Aam Aadmi Party took part in the discussion on the Bill and spoke for 02 minutes.

The Hon'ble Chief Minister and Finance Minister, by way of reply to the discussion on the Bill, spoke for 31 minutes and 01 minute respectively.

During Clause-wise consideration of the Bill, Sub-Clause (2) of Clause 1, Clause 2 to 28 collectively, Sub-Clause (1) of Clause 1 and Title were put to the vote of the House and carried unanimously.

The motion moved by the Finance Minister that "The Punjab Goods and Services Tax (Amendment) Bill, 2023 be passed" was put to the vote of the House and carried unanimously.

# 2. <u>The Punjab Fiscal Responsibility and Budget Management (Amendment) Bill, 2023</u>

The Finance Minister introduced The Punjab Fiscal Responsibility and Budget Management (Amendment) Bill, 2023 and moved that the Bill be taken into consideration at once.

The motion was put to the vote of the House and carried.

Shri Avtar Singh Junior, M.L.A. took part in the discussion on the Bill and spoke for 7 minutes.

Sardar Harpal Singh Cheema, Finance Minister, by way of reply to the discussion on the Bill, spoke for 06 minutes.

During clause-wise consideration of the Bill, Sub-Clause (2) of Clause 1, Clause-2, Sub-Clause (1) of Clause 1 and Title were put to the vote of the House and carried.

The motion moved by the Finance Minister that "The Punjab Fiscal Responsibility and Budget Management (Amendment) Bill, 2023 be passed" was put to the vote of the House and carried.
